SUPPLEMENTARY CONTRACT FOR PERFORMANCE
OF REHABILITATION AND BETTERMENT WORK

THIS SUPPLEMENTARY CONTRACT, made this 31st day of January 1961, by and among THE UNITED STATES OF AMERICA, hereinafter called the United States, acting through the Regional Director, Region 1, Bureau of Reclamation, hereinafter called the Contracting Officer, and the BIG BEND IRRIGATION DISTRICT, the BOISE-KUNA IRRIGATION DISTRICT, the NAMPA & MERIDIAN IRRIGATION DISTRICT, the NEW YORK IRRIGATION DISTRICT, and the WILDER IRRIGATION DISTRICT, hereinafter called the Districts, and the BOISE PROJECT BOARD OF CONTROL, the operating agency of the Districts, hereinafter called the Board, their successors and assigns,

WITNESSETH, THAT:

2. WHEREAS, the United States, the Districts, and the Board entered into a contract dated October 5, 1960, for performance of certain rehabilitation and betterment work, and the parties desire to modify the provisions of such contract;

NOW, THEREFORE, in consideration of the mutual and dependent stipulations and covenants herein contained, it is mutually agreed by and among the parties hereto, as follows:

3. Article 5 of the October 5, 1960, contract is amended by adding at the end thereof the following additional item:

(j) Repair sink holes upstream of Boise River Diversion Dam.

4. Article 6 of the October 5, 1960, contract is amended by substituting

the figure five hundred thirty-nine thousand two hundred thirty-two dollars
(\$539,232.00) for the figure five hundred nine thousand two hundred thirty-
two dollars (\$509,232.00) in the sixth line from the top of page 4 of such
contract.

5. Except as specifically amended herein, all provisions of the
October 5, 1960, contract among the parties hereto shall remain in full
force and effect.
